SUBJECT: Draft Technician Take-Home Vehicle Policy

I recommend that the District consider adopting a policy to allow Field Technicians the opportunity to utilize their assigned District vehicles as take-home vehicles, following specific criteria, when there is a clear and strong benefit to the District. The calculations below represent one (1) particular instance in which allowing a Field Technician to utilize a take-home vehicle would present such a benefit. Please review the draft policy in preparation for discussion at the Board meeting. Thank you for your attention to this matter.

#### Technician Take-Home Vehicle Policy

#### Applicability and Purpose

The intent of this policy is to state the responsibilities and accountability of the District and District field employees regarding District take-home vehicles and their usage, operations, maintenance, refueling, and the coordination of these activities. District field staff will have the opportunity to take their assigned work vehicle home to their residence at the sole discretion of the Executive Director, only when it provides a clear and strong benefit to the District and the work function. This policy supports reduced costs, better management of District resources, reduced claims and liabilities, and designation of areas of responsibility and accountability.

#### Vehicle Security

- District vehicles covered by this policy must be identified as belonging to the Pasco County Mosquito Control District
- All District take-home vehicles shall be parked in the driveway or garage of an occupied dwelling when not in use
- All vehicles must be locked when not in use and all equipment and valuables within the vehicle (whether District or personal) placed in a location which is out of sight of people passing by when possible
- Missing or damaged vehicles will be reported immediately to the Police or Sheriff's Department and the employee's immediate supervisor

This policy will be applicable when there is a clear and strong benefit to the District and if all of the following criteria are met;

#### Take-Home Assignment Criteria

- Employees authorized for take-home vehicle assignment must sign a document acknowledging
  receipt and understanding of this policy, which will be kept in the employee's personnel file. A
  copy of this policy will be given to the employee's immediate supervisor and shall be kept in all
  District vehicles of employees who operate District take-home vehicles. The District will
  maintain a Take-Home Vehicle Assignment file.
- Take-home vehicles will only be assigned to full-time District employees who:
  - Have reviewed this and all District policies with acknowledgement of receipt
  - Refrain from use of alcohol and controlled substances, with exception of prescription medications, before and while driving the District vehicle
  - Refrain from allowing any individual other than the assigned employee from driving the District vehicle
  - Refrain from driving out of Pasco County except with the express permission of the Executive Director
- Take-home vehicles are to be used for the conduct of District business

In addition, employees are permitted to travel to and from work in accordance with Internal Revenue Service rules and regulations. District vehicles, as a general rule, should not be used to perform personal business that detracts from District operations. However, in some instances, technician take-home vehicles may be used to perform minor, personal errands so long as the

errands are conducted to and from work, are brief in nature, and do not detract from the employee's activities as a public servant.

- Employee must not pass the District headquarters to get to their assigned area
- Employee is required to visit the office at a minimum of once weekly as directed by their supervisor to replenish chemicals, fuel, and other necessary supplies and equipment and to submit necessary paperwork, etc.
- Employee must check in at a minimum of twice daily with their supervisor via phone at the start of their shift and at the end of each work day
- Employee is required to clock in and maintain time-clock entries on District phone (via use of downloaded app)
- Employee shall keep the vehicle in tidy condition at all times, within reason and report any damage to their supervisor directly following the incident
- Employee must have excellent history of taking good care of District equipment
- Employee will be charged fringe benefit tax to the State of Florida

Any exception to this Policy must receive prior approval from the Executive Director. Take-home vehicle status will be reviewed on at least an annual basis. The District considers assignments of take-home vehicles to be temporary and as such, subject to review and revocation at any time.
